Once archived, campaign statements can be viewed by visiting the public campaign finance disclosure portal. This system ensures the highest level of transparency and accountability so that voters and members of the public can be fully informed. All Commissioners serve single four-year terms. The President of the Commission shall serve full time and receive a salary. The Commission can also penalize violators. [1] Organization The Commission comprises five members. Signature verification forms shall be signed and presented for each user, candidate or principal and the Treasurer of the Committee. Two commissioners are appointed by the governor. In addition, all committees must have a signed signature verification card (PDF) on the file with the city clerk office to submit declarations by electronic means.
